# **Background**

- Georgia Revenue Service (Joint Tax and Customs Administration) is the oversight agency which issues permits, regulates and supervises the conduct of gaming
- Georgian Gambling Legislation is based on two basic principles:
- ✓ Ensuring that gaming is conducted in a fair and open way
- ✓ Protecting children and other vulnerable persons from being harmed or exploited by gambling



# **Gambling Business in Georgia**

- There are couple of choices for starting Gambling Business in Georgia:
- ✓ Casino
- ✓ Slot Machines
- ✓ Table Games
- ✓ Bookmaker
- √ Bingo
- ✓ Lotto
- ✓ Promotional Drawing Game



### **Permits**

# Permits are issued electronically. No need to visit Tax department for providing documents and/or receiving permits

- Casino, Slot Machines, Bookmaker, Bingo, Lotto permits are issued for 5 years
- Promotional Drawing Game Permit is issued for 1 year
- Table Games Permit:
- ✓ Table Games Permits have been recently introduced to Georgian market, due to the increasing interest to Texas Hold'em Poker
- ✓ Companies possessing Casino and Slot Machine Club permits in TBILISI, are allowed to acquire Table Game Permit
- ✓ Table Game Permits are issued for a period of time until casino's or/and slot machines permits are valid
- ✓ Tbilisi Casino Permit holders are allowed to open 3 Table Game Clubs in any part of Georgia FOR FREE
- ✓ Tbilisi Slot Machine Permit holders are allowed to open **1 Table Game Club** in any part of Georgia FOR FREE
- ✓ Each following Gaming Club: 10 000 50 000 GEL



### **Fees & Taxation**

Annual fee for PERMIT varies according to the type of permit and location of your business:

### Casino:

Annual, fixed, state fee is levied, which is paid each year in equal payments, in the beginning of the year

#### **Annual Fees:**

• **5 000 000 GEL** (with exceptions)

These exceptions vary according to the location of the company:

- ✓ Batumi, Kobuleti, Borjomi, Bazaleti Lake 250 000 GEL
- ✓ Akhaltsikhe 100 000 GEL

### Some of the regions are totally exempt from ANNUAL STATE FEES:

- ✓ Gudauri, Khazbegi, Bakuriani, Sighnagi and Tskaltubo are totally exempt from annual fees with no conditions
- ✓ Batumi, Kobuleti, Khelvachauri, Anaklia and Ganmukhuri are exempt from an annual fee on a condition that 100 or 80 room, newly built hotels within Casino will be built





Exempt from annual fee + 100 Room Hotel Exempt from annual fee + 80 Room Hotel Exempt from annual fee with no conditions





#### **Land Based Fees & Taxation**

### Casino

#### **Quarterly fees:**

**For each Casino Table - 15 000 - 30 000 GEL** (Casino Tables are not subject to quarterly fees during tournaments)

#### **Taxation:**

Personal income tax (salaries) – 20%; Property tax – up to 1%; Corporate Income Tax– 15%; W/H - only during tournament – 20%



### **Slot Machines**

#### **Annual State Fees:**

50 000 - 1 000 000 GEL (Tbilisi - 1 000 000 GEL)

In case of locating Slot Machines within Casino in TBILISI: 100 000 GEL

#### **Quarterly Fees:**

For each Slot Machine: 1500 - 3000 GEL

#### **Taxation:**

Personal income tax (salaries) – 20%; Property tax – up to 1%;



### **Table Games**

#### Annual state fees:

- ✓ Casino Permit holders are allowed to open 3 Gaming Clubs in any part of Georgia FOR FREE
- ✓ Gaming Machine Permit holders are allowed to open 1 Gaming Club in any part of Georgia FOR FREE
- ✓ Each following Gaming Club: 10 000 50 000 GEL

#### **Quarterly fees:**

For each Table in Table Game: 3 000 – 10 000 GEL

#### **Taxation:**

Personal income tax (salaries)— 20%; withholding liability- only during tournament – 20%; Property tax – up to 1%;



### Bookmaker

**Annual state fees:** 30 000 - 300 000 GEL

**Quarter fees: Land Based - Free** 

Land based Taxation:

Personal income tax (salaries) – 20%; Property tax – up to 1%;

### Bingo/Lotto

**Annual state fees:** 15 000 GEL

**Quarterly fees: Land Based - Free** 

**Land Based Taxation:** 

Personal income tax (salaries)— 20%; Corporate Income Tax— 15%; withholding liability — 20%; Property tax — up to 1%;



## **Promotional Drawing Game**

Annual fees: 15 000 GEL

**Quarterly fees:** 

Land Based: 10% of Prize Fund

#### Land based taxation:

Personal income tax (salaries) – 20%; Corporate Income Tax– 15%; withholding liability – 20%; Property tax – up to 1%;



# Time for issuing permit

Permit is issued in 20 days (for free)

 Though, if a company requires swift services, following Service Fees are added:

- Issuing permit in 10 days 400 GEL
- Issuing permit in 5 days 800 GEL
- Issuing permit in 1 day 2000 GEL



#### New approaches and recent changes:

### According to recent changes in legislation:

- 1. Slot Machines, Table Games & Bookmakers are not taxed on CIT (Corporate Income Tax 15%)(Except iGaming)
- ✓ By introducing fixed and stable Annual Fee, we eliminated always questionable 15% CIT
- ✓ Business feels more secure
- ✓ Budget does not face risk of loss



#### According to recent changes in legislation:

### 2. W/H (Withholding liability): Payouts are not taxed for Casino, Slot Machine Clubs, Table Games Clubs and Bookmakers

Only if a winner <u>requests</u> withholding tax from a company, a company is obliged to withhold the tax

This exemption is not active during Table Game Tournaments in Casinos: Example: if a players won 10 000 GEL in CASINO, and 10 000 GEL in the tournament, Casino pays out TOTAL 10000 GEL, though withholds 20% on the payout of tournament (8 000%)





#### According to recent changes in legislation:

### 3. Property tax for permit as an intangible asset has been eliminated

Before these changes, permit owner was obligated to pay property tax for a permit as an intangible asset up to 1%

**Example:** As Casino permit is issued for 5 years, Casino Permit Holder had to pay 5 000 000 GEL annually, which summed up to 25 000 000 GEL in 5 years. According to past legislation, permit holder was obliged to pay Property Tax on the permit "up to 1%" of 25 000 000 GEL in the beginning of first year.

Also, if permit holder revoked the permit in year or two, the total paid amount for property tax was not re-paid.

4. Table Game Clubs, Slot Machine Clubs and Bookmakers are freed from an obligation to install Cash-registers for Gambling and Gainful Game purposes only. All refreshments, entertainments, and other services require cash-registers



## iGaming permits

Separate permit for organizing iGaming is not issued, it is only issued to the land-based permit holders (in Georgia). Gambling and gainful games may be arrange by internet for:

- ✓ Casino
- ✓ Slot machines
- √ Bookmaker
- ✓ Promotional Drawing Game

A company in Georgia is prohibited from providing iGaming services to an offshore company



## iGaming Fees

- iGaming permit holders pay quarterly fees.
   Quarterly fees are determined by Local
   Administrations, which vary from 30 000 to
   60 000 GEL
- Basic iGaming language sites are: Georgian, English, Russian. Also other languages are operational
- Live stream on line gaming from Casinos are permitted



### **iGaming Taxation**

- Casino: Personal income tax (salaries)— 20%, Corporate Income Tax

   15%, property tax up to 1%, withholding liability— only during
   tournament -20%
- **Slot Machines:** Personal income tax (salaries) 20%, Corporate Income Tax 15%, Property tax up to 1%.
- Bookmakers: 5% of the turnover (gross revenue). Personal income tax (salaries) -20%; property tax-up to 1%.
- Promotional Drawing Game: personal income tax (salaries)— 20%; property tax — up to 1%, Corporate Income Tax— 15%; withholding liability - 20%





# Year of 2013 and 2014 Statistics for Annual State Fees

### Annual fees have increased approx 200%

#### Number of operating Casino permits:

- 3 in Tbilisi (15 000 000 GEL)
- 4 in Batumi (1 000 000 GEL)
- 2 in Batumi newly built hotel (FREE)
- 4 in Tskaltubo (FREE)
- 1 Khazbegi (FREE)
